DISCRIMINATION AGAINST HEALTH AND SAFETY REPRESENTATIVE(S)	
<p>whether a health and safety representative(s) (employee and/or contractor) has been <u>discriminated against</u> in employment for carrying out his/her duties</p> <p>[s 68C - Schedule 5, Division 5]</p>	<p>the health and safety representative(s) (employee and/or contractor) claiming discrimination</p> <p>[s 68C - Schedule 5, Division 5]</p>
DISQUALIFICATION OF HEALTH AND SAFETY REPRESENTATIVE(S)	
<p>whether a health and safety representative ought be disqualified</p> <p>[s 31(1) - Schedule 5, Division 3]</p>	<p>the operator, a work group employer or at the request of a group member of designated work group (workforce representative)</p> <p>[s 31(1) - Schedule 5, Division 3]</p>
