Proposed General Order to deal with the effects of the COVID-19 Pandemic

Friday, 3 April 2020

- 1. The Western Australian Industrial Relations Commission (the Commission) is aware of the circumstances of the COVID-19 pandemic and the effects on employees and employers of the responses by governments, both Federal and State¹. Those responses have placed significant restrictions on the community and affect the overall economy of the State. The Commission also notes the need for and benefits of greater flexibility in employment arrangements to employers, employees and the economy generally².
- 2. The Commission also notes the Statement issued by the Fair Work Commission on 1 April 2020 ([2020] FWCFB 1760) and the detailed information provided there. We note the provisional views expressed by the Fair Work Commission and the proposed variations to certain Modern Awards.
- The Commission also notes the requirements of s 26(1) of the *Industrial Relations Act* 1979 (WA) (the Act) and intends to take account of those matters specified as being required for consideration.
- 4. In those circumstances, the Commission is provisionally of the view that it is appropriate to, of its own motion, and subject to receiving and considering any submissions, issue a General Order pursuant to s 50 of the Act, to vary awards to provide measures designed to assist employers and employees. The objective in doing so is, to the extent possible,

- to enable businesses to continue to operate and to preserve employment and the continuity of employment.
- In doing so, we note that the awards of the Commission are set in a different legislative context to the Modern Awards of the Fair Work Commission and the Act contains different protections to those contained in the Fair Work Act 2009 (Cth).

Proposed General Order

- 6. The proposed General Order would provide for:
 - unpaid pandemic leave of up to two weeks' unpaid leave if an employee is required, by government or medical authorities or acting on medical advice, to selfisolate or is otherwise prevented from working by measures taken by government or medical authorities in response to the COVID-19 pandemic;
 - twice the amount of annual leave at half pay.
- 7. The Commission notes that unlike a number of the Modern Awards of the Fair Work Commission, awards of the Commission do not generally provide for annual leave to be taken in advance. In the current circumstances of the COVID-19 pandemic, the Commission considers that it may be appropriate, as a temporary measure, to allow for an employer and employee to agree to an employee taking a period of annual leave in advance subject to certain conditions being met.
- 8. These arrangements would be subject to the conditions set out in the attached Schedule and would be temporary, applying until 30 June 2020. They may be extended by application or at the initiative of the Commission.
- 9. We note that parties to awards are entitled to negotiate with a view to resolving terms and conditions most suited to the needs of their industries, and we encourage them to do so. The Commission will expedite the process of reflecting any agreements reached or determining any disputes.

Timelines

10. Given the circumstances of the impact of the COVID-19 pandemic, the Commission proposes to move quickly. Any person wishing to respond to the Commission's provisional view and the proposed variations is to lodge electronically, a written submission by midday on Thursday, 10 April 2020. Schedule A – Provisions relating to the COVID-19 pandemic

1. Unpaid pandemic leave

- a) Subject to subclauses (b) and (c), any employee may elect to take up to two weeks' unpaid leave if the employee is required, by government or medical authorities or acting on medical advice, to self-isolate or is otherwise prevented from working by measures taken by government or medical authorities in response to the COVID-19 pandemic in circumstances where the employee is required to work at premises operated by an employer.
- b) The employee must give their employer notice of the taking of leave under subclause (a) and of the reason the employee requires the leave, as soon as practicable. This may be a time after the leave has started.
- c) The employee who has given their employer notice of taking leave under subclause (a) must, if required by the employer, give the employer evidence that would satisfy a reasonable person that the leave is taken for a reason given in subclause (a).
- d) Leave taken under subclause (a) does not affect any other paid or unpaid leave entitlement of the employee and counts as service for the purposes of entitlements under this Award.

e) Such leave:

- is available in full immediately rather than accruing progressively during any period of service;
- (ii) will be available until 30 June 2020 (unless extended by further variation depending on the duration of the COVID-19 pandemic); and
- (iii) Will be available to full time, part time and casual employees (it is not prorata).
- (f) It will not be necessary for employees to exhaust their paid leave entitlements before accessing unpaid pandemic leave.

- (g) Such unpaid leave does not operate on a 'per occasion' basis and is available only once for those employees compelled to self-isolate, even if they are required to self-isolate on more than one occasion.
- (h) Those caring for others who are compelled to self-isolate are not entitled to unpaid pandemic leave.

2. Annual leave at half pay

- a) Instead of an employee taking paid annual leave on full pay, the employee and their employer may agree to the employee taking twice as much leave on half pay. Example: Instead of an employee taking one week's annual leave on full pay, the employee and their employer may agree to the employee taking two weeks' annual leave on half pay. In this example:
 - The employee's full pay for the two weeks' leave is the same as the pay the
 employee would have been entitled to for one week's leave on full pay
 (including leave loading where appropriate); and
 - One week of leave is deducted from the employee's annual leave accrual.
- b) Any agreement to take twice as much annual leave at half pay must be recorded in writing and retained as part of the employee's employment record.

3. Granting annual leave in advance

- a) An employee may take a period of annual leave in advance if all of the following conditions are met:
 - (i) The employer and employee must make a written agreement to the employee taking the period of leave in advance;
 - (ii) The written agreement must state the amount of leave to be taken in advance and the date on which the leave will commence; and
 - (iii) The written agreement must be signed by both the employer and the employee (and a parent/guardian if the employee is under 18).
- b) The employer must keep a copy of the written agreement as part of the employee's employment record.
